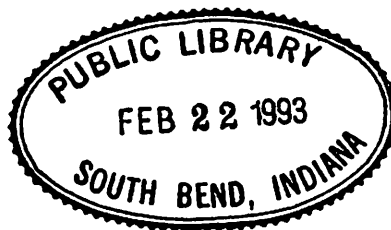

- ORDWAY, Peter, MA Line, S22924, sol enl at Newbury in Essex Co MA, he appl 27 Sep 1833 at Hopkinton in Merrimack Co NH aged 78
- Samuel, NH Line, S22429, sol lived at Hillsborough NH at enl, he appl 18 Aug 1832 Orange Co VT aged 69 a res of Bradford VT
- ORE, Baltus or Baltus Oar, NY Line, S43750, appl 1 May 1818 at Minden in Montgomery Co NY, on 5 Jul 1820 sol had moved to Herkimer in Herkimer Co NY & gave his age as 61 with no family
- Jacob, NY Line, S14059, sol was b at Johnstown in Montgomery Co NY & he lived at Minden NY at enl, he appl 22 Aug 1833 at Canajoharie NY aged 71
- OREAR, Daniel, NC & VA Line, S31892, sol was b in 1758 or 1759 in Fauquier Co VA & he lived there at enl & afterwards moved with his father to Wilkes Co NC & also enl there & later vol at Charlestown SC & after his srv sol lived in NC for 30 yrs then moved to Hancock Co GA for several yrs then moved to Bledsoe Co TN & about 1823 he moved to Franklin Co TN where he appl 4 Mar 1834, in Sep 1838 he gave his post office as Lafayette in Walker Co GA & in Apr 1839 he had moved to Chattooga Co GA to be with his children, in 1839 a Benjamin Orear was of Chattooga Co GA relationship ???
- Daniel (shown as O'Rear), VA Line, S7376, appl 17 May 1850 Prince William Co VA aged 90, sol enl with 2 of his bros, towit; Jesse & John Orear from Prince William Co VA, sol's bro Enoch Oread made aff'dt in Prince William Co VA 17 May 1850, an inquiry was made for sol's son Thos Orear on 15 Mar 1857 from Somerville (state not given), sol's father's children were; Jeremiah b 16 May 1744, Mary b 21 Aug 1745, Benjamin b 20 Feb 1747, John b 21 Mar 1749, Elizabeth b 7 Apr 1751, Margret b 13 Feb 1753, Jesse b 14 Jan 1756, the claimant Daniel b 23 Dec 1759, William b 1 Dec 1761 & Enoch b 18 Feb 1763, sol father was John Orear
- John (shown as O'Rear), VA Line, S31285, sol was b in Prince William Co VA & he lived in Prince Wm. Co VA at enl & he appl 8 Sep 1832 Montgomery Co KY aged 83 & had lived there some 23 yrs, one Will Orear aged 71 was of Montgomery Co KY on 1 Dec 1832 but no relationship to sol was given
- OREM, Spedden or Spedden Oram, MD Sea Srv, R7809, appl 22 Jun 1838 Talbot Co MD aged 77 & he had lived there at enl, he signed as Spedden Orem, Sr., a Manlove Hazel & Solomon Barnett were wit's
- ORENDORF, Christian or Christian Orndorff, MD Line, S38281, appl 16 Apr 1818 Frederick Co MD, in Nov 1820 sol had moved to Jefferson Co VA, sol d 1 Oct 1824 leaving children (not named), a son-in-law was referred to only as Mr. Shafer
- ORGAN, Cornelius, Rachel, Cont & VA Line, R16856, sol appl 6 May 1818 at Kent in Putname Co NY aged 58, sol had enl in VA, sol m Rachel Barrett at Bedford NY in Apr or May 1782, sol d 6 Oct 1818 aged 57 ? at Kent NY & his wid d there 18 Sep 1836 aged 73 yrs 3 mths leaving children who in 1852 were; Mary wife of Jesse Cole, Esther wife of Abijah Yeomans, Sally wife of Gilbert Shaw, Reuben aged 56, Rachel wife of Hiram Cole & Betsey wife of Nathaniel Nichols, children's births were; William b 27 Aug 1782 & d 4 Dec 1822, Samuel b 1 Sep 1784, Mary b 15 Sep 1787, Esther b 29 May 1790, Sarah b 11 Dec 1792, Reuben b 16 Sep 179?, Rachel b 12 Dec 1799, Elizabeth b 19 Dec 1801 & Magers b 30 Mar yr?
- Isaac or Isaac Orgin, Elizabeth, Cont & MA Line, W24370, see as Isaac Orgin
- Isaac, BLW #s 4782 & 3613-100-10 Aug 1789 to Richard Platt, srv as a Drummer in the MA Line
- John, Sr., Cont & PA Line, BLW #1029-100-6 Mar 1822, sol had enl with his 2 sons Mathew & John, Jr. & John, Sr. was killed at the Seige of York, the son Matthew Organ appl 25 Feb 1822 Allegheny Co PA & a John & Mary Cann were witnesses (the said John Cann had srv with the sol & his sons)
- John, BLW #10176-100-5 Dec 1795, srv as a Pvt in the PA Line
- John, Catharine, PA Line, W6770, wid appl 28 May 1839 Westmoreland Co PA aged 82, sol & wid had m 17 Jul 1783, sol d 4 Aug 1813, on 27 Apr 1852 a daughter Susanna Coulter aged 62 made aff'dt in Allegheny Co PA & stated wid d 6 Dec 1848 leaving 4 children; John, William & Mathew Organ & Susannah Coulter
- Matthew or Mathew, Cont & PA Line, S40226, sol enl in Bedford Co PA, he appl 4 Feb 1820 Washington Co PA aged 62 with a wife & 2 children; Resin aged 17 & Jemima aged 12 & grandchildren; Matthew Duncan aged 4 & Dan'l Duncan aged 3 yrs
- Matthew, BLW #10168-100-23 Jan 1796, srv as a Pvt in the PA Line
- ORGEN, Dennis, Lois, MA Line, W19939, sol m Lois Sawyer 10 Dec 1785 at Pepperell MA & his name was shown as Dennis Orgain in the m records, wid appl 15 Jul 1845 Orleans Co VT aged 85 a res of Sherbrook Co in the District of St Francis in the Prov of Canada, sol & wife moved to Stoddard NH about 1793 & about 1801 they moved to Acworth NH where sol was living when he died while on a visit to see his daughter Judith the wife of Eli Perkins in 1815, one Eli Perkins the nephew of Eli Perkins stated sol's daughter Judith m his uncle Eli about 1809, the said Judith (Orgen) Perkins made aff'dt 23 Aug 1845, sol & wife raised a family of children but only Judith was named, a David Wallace & his wife Betsey of Compton in Sherbrook Co in Canada made aff'dts 14 Jul 1845
- ORGIN, Isaac or Isaac Organ, Elizabeth, Cont & MA Line, W24370, sol m Elizabeth Hollowell 3 Dec 1792 at Lynn in Essex Co MA, sol appl 30 Mar 1818 at Boston MA, in 1823 sol had returned to Essex Co MA & gave his age as 62 with a wife aged 60 & 3 children; Isaac 27 who had a family, Eliza & Mary Ann both were married but their last names & ages were not given, wid appl 3 Aug 1838 at Lynn in Essex Co MA aged 71, sol d 29 May 1831
- O'RIAN, John or John O'Rion, MA Line, S36712, appl 22 Jun 1818 at Limington in York Co MA (ME) aged 72, in 1820 sol had a wife Molly aged 82
- O'RIEN, Joseph, BLW #10190-100-31 Mar 1795 assignee Simon Rigby, srv as a Pvt in the PA Line
- O'RION, John or John O'Rian, MA Line, S36712, see John O'Rian
- ORISH, James, BLW #12443-100-14 Jul 1792 assignee Robt Means, srv as a Pvt in the VA Line
- ORLOP, Frederick, Hannah, NY Line, W21871, wid appl 5 Jul 1837 Albany Co NY aged 77, sol m Hannah Reese 13 Mar 1780 at Schenectady NY but both were living at that time in Watervliet NY & sol's bro Henry Orlop, Catherine Orlop & Andries Myers were at their wedding (both Henry & Catherine were dec'd in 1837), sol's bro William Orlop aged 78 made aff'dt 20 Jul 1837 at Watervliet NY, sol d 16 Jul 1830, one Jacob Rose of Watervliet NY was aged 72 on 21 Sep 1842 made aff'dt 20 May 1843 & stated he was b at Watervliet NY & knew both sol & wife before they were m & afterwards
